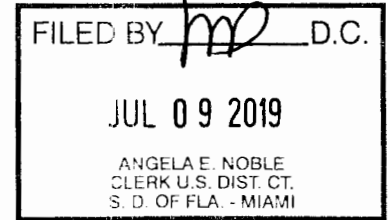

Dear District Court Judge Ungaro,

Judge I would like to enter in a request/ plea for you to please allow time to listen to arguments in favor of allowing US Stem Cell to offer peer/ review of other professional Drs and researchers in this area of stem cell therapy.

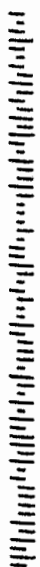

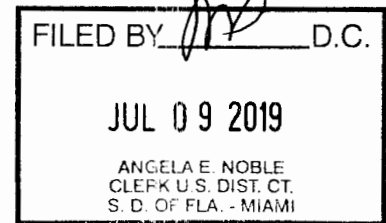

Please do not declare my own cells drugs. And please do not destroy cells taken from me.

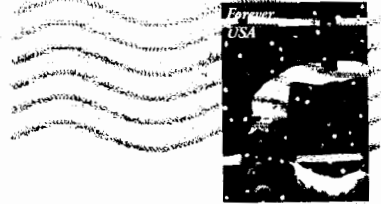

I received notice that on June 25, 2019, that you directed US STEM CELL, INC, US STEM CELL CLINIC, LLC by Order and Injunction to no longer receive, process, and distribute SVF Product. This action directly affects me since I have MY OWN stem cells stored with this company. I made this decision on April 10, 2019 and I paid \$2000 for this service. I strongly believe that there was no definitive reason for your action other than the intervention of government in its citizen's lives and the ongoing greed of the pharmaceutical industry. No matter what the FDA (who I believe is controlled by money poured into it by the pharmaceutical industry) determines to be the safety and effectiveness of stem cell therapy, I clearly have the constitutional right to use MY OWN stem cells that were harvested from MY OWN BODY, whatever way I choose, without government intervention. Recent research and studies have produced overwhelming evidence of the effectiveness of stem cell therapy in many situations. I believe that continued research will further prove stem cell therapy to be as revolutionary as Penicillin or X-Ray technology. The FDA's direction from you to destroy MY stem cells, which are an extension of MY BODY makes no sense whatsoever and borders on infringement of my constitutional rights. I made the decision to store MY STEM CELLS with US Stem Cell, INC for MY USE or that of MY DIRECT DECENDANTS in the future. PRESERVATION OF BIOLOGICS OF GARY MOTYKIE

Dear Sir or Madam:


We represent the interests of Gary Motykie in connection with his stem cells or other biologics presently in the custody of US Stem Cell, Inc. or related entities. The purpose of this letter is to request that Motykie's biological materials be preserved and permitted to be sent to him rather than destroyed pursuant to the Court's June 28, 2019 Order (¶ 10 at 9).

On June 28, 2019, Motykie, who is a California physician and surgeon, received email correspondence from US Stem Cell advising him of the Court's order and the instruction to destroy his biological materials, among others. Motykie has asked us to request that the Court permit his materials to be sent to him rather than allowing them to be destroyed.

While I understand from a cursory review of the matter the case entails adjudicated claims brought by the Food & Drug Administration claiming that the biologic materials were converted into therapeutic materials outside of the FDA's regulatory process, the materials sought are Motykie's own cells and not a processed therapeutic material.

Please let me know if the scope of the Court's order will permit the return of my client's biological materials so arrangements can be made with US Stem Cell.

I am VERY disturbed over your decision to close down US STEM CELL INC in Florida. I have my own stem cells banked there for the preservation of my OWN health and longevity.




Dear Ursula Umgaro:


My name is Kelly Boyette, I resides in Janesville, Wisconsin. I am writing this letter on behalf of Dr. Robyn MacKillop, who resides in Salem, Oregon, and has recently received news regarding an injunction issued for all patient-owned stem cell tissue banks to be destroyed in 30 days at U.S. Stem Cell, Inc., located in Sunrise, Florida.

Dr. MacKillop lives with Multiple Sclerosis (MS) and is now wheel-chair bound. Because of the progression of her condition, she had stem cells extracted from HER OWN adipose tissue for the purpose of using them to combat the effects of the MS. 
A high probability exists that harm will be done to my physical person should you continue the order to destroy my stem cells. Currently, they are in the possession of U.S Stem Cell Inc.

We want them transferred to Viacord, or other qualified stem cell storage facility.

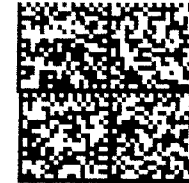

We request, regarding the stem cells of Nona K Arnold, that the injunction be modified.



To Whom It May Concern:

It has come to my attention that under the jurisdiction of the Southern District of Florida, U.S. District Judge Ursula Ungaro issued an Order and Injunction that generally prohibits US Stem Cells, Inc., US Stem Cell Clinic, LLC and other from receiving processing and distributing SVF Product. I am writing to you to explain how this decision is going to forever change many lives. The decision you are making on the basis that the therapy that is being offered does not help is false. Like any medical procedure or therapy not all people will see positive results from it and when we started my mom on Stem Cell Therapy a few years ago we weren't sure if it would help her or if we were just spending money on false hope that her quality of life could be improved.

I want to tell you a little about my mom and our family. I want you to, hopefully, understand the people that your decision is affecting. My mom is my only parent. She decided to leave my abusive father when I was a baby as she knew it was not the best place to raise a child. She did this in 1971 when being a single parent was not a common thing. I think I was the only child in my elementary school that came from a single parent home. My mom gave up everything for me when I was a child. I was her only focus and she raised me with all the right values and taught me to care for people and be compassionate. She taught me to work hard and always be honest. She has made me the successful business woman I am today. She is my life and I could not imagine living a single day without hearing her voice or talking to her. She is the strongest woman I have ever known. She is my family, my heart and someone I would do anything for. There isn't a person that meets her that doesn't fall in love with her. She is the kindest person I know and would do anything for anyone and I'm not just saying this because she is my mom.

My mom is a client at US Stem Cells, Inc and she has banked her personal tissue with them for use in the treatment of her COPD and Emphysema. She was diagnosed with Lung Cancer in 2005. She had to have a lobectomy of her upper left lobe. We were lucky that they were able to remove all the cancer without having to put her through radiation and chemotherapy, which can be more destructive to the body than the surgery and cancer can be sometimes. You can imagine our relief when we got the news that all the cancer was able to be removed surgically. I am so happy to say that she has been cancer free since then and we have not had any

problems in that area. Although it is always a concern that the cancer will return or will go into metastasis we have had a little less to worry about.

Her symptoms from the COPD and Emphysema can be quite severe. She was prescribed Oxygen at night while she was sleeping as her Oxygen Intake levels would drop severely while she was at rest. In addition to the Oxygen at night she was having to do Nebulizer treatments, daily lung pills and daily inhalants in addition to having to do rescue inhalants at certain times. Obviously having to take so many medications is taxing in itself and then to see that the medications were having little to no improvement for her I started to look outside the proverbial box. This is when I ran across an article about stem cell therapy in a medical journal.

I did a lot of research along with my mom before we decided to move forward and try this therapy. We knew it wasn't covered by insurance but there is no price that could be put on my mom's life. We knew it wasn't guaranteed and we knew it wasn't a cure. What we were hoping for is a better quality of life for her. For her to be able to walk across the house without getting out of breath. 

Pharmaceutical companies are losing money as these technologies move forward and become better tested and improved. The FDA is jaded and although they state they are looking out for everyone's interest it isn't always the case. Every treatment has risks, whether it is regulated or not. Stem Cells are not a drug. I would equate it as about the same as a blood transfusion. If I had my blood banked, as I did when my mom had her lung lobectomy, in case a transfusion was needed would that have the same regulations? Would my blood then be considered a drug?

I am sorry that this therapy may have not worked for some people. I am sorry that they have had adverse reactions. It is a risk we knew we were taking when we decided to go this route. The fact is that this therapy does work for my mom. She has had improvement. We are lucky that she is a success story. By taking away this therapy you are sentencing my money to death at a much sooner time. You are taking away my family, my mom, my biggest supporter, my rock and the most important person in my life. You are saying that her life is not worth anything. You are saying that even though we found something that works for her and is helping her it doesn't matter. You are saying that her life doesn't matter.

I am pleading with you to reverse this. Let us continue this treatment. Let me continue to have my mom.

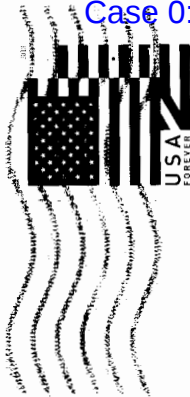

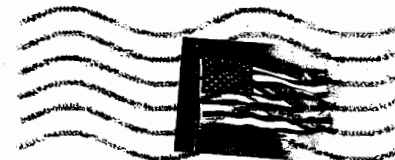
Please note that we are working diligently to consider all options and as always, the health of our patients is a priority.

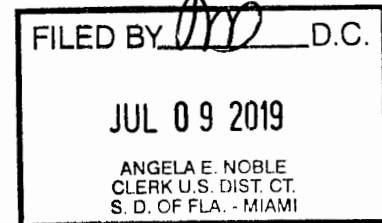

USA v US Stem Cell Clinic and others, Case 18-cv-61047-UU

Dear Justice Ursula Ungaro;

I am a 71-year old retired physician. Suddenly one day in 2018, I was unable to lift my arm to hang up a coat. A few hours later, weakness of chest wall muscles made breathing difficult. The next day, I had trouble swallowing. Every day thereafter for a month, disability worsened.

Steroid infusions at the University of Utah Hospital sent my blood pressure into the stroke zone, but didn't stop the progression of muscle weakness and brain stem dysfunction. By the time I was given gamma globulin infusions by a multiple sclerosis specialist, my arms were so weak I had to bend my head down to the plate to eat. I was losing more than a pound a day and I had lost control of bowel and bladder. Gamma globulin infusions stopped the progression of my disease, but it wasn't until I was able to access an intravenous autologous stem cell infusion with stromal vascular fraction a few weeks later, that I started to recover.

I had a relapse of this disease later in 2018, and was treated with banked stem cells, much more quickly than the first time. And more quickly, the disability reversed and I recovered. This disease was initially diagnosed as autoimmune encephalomyelitis, but retrospectively, it resembles acute flaccid myelitis, which has recently been paralyzing children around the country. According to the CDC (at <https://www.cdc.gov/acute-flaccid-myelitis/hcp/clinical-management.html>), there is no evidence that any conventional treatment is beneficial to individuals stricken by acute flaccid myelitis. I wrote to the CDC about my experience but never received a response.

I now live with occasional symptom recurrence, which keeps me in fear of another relapse, though so far, the symptoms have intermitted and not progressed on the downhill spiral that I experienced twice last year. Anxiety about return of this disease is now also augmented by receipt of notice that my banked stem cells must be destroyed because of the FDA's dispute with the clinic in which they are maintained.

I have read the FDA's report of violations by US Stem Cell Clinic, LLC, and understand why regulators demand that this facility come into better compliance with standards. However, it appears that the production of stromal vascular fraction by this clinic is the prime motivator of

the FDA's action against it. Considering how many times the FDA has approved dangerous drugs in its almost sixty-year history, current officials do need to be cautious. When I was a practicing physician, many drugs approved by the FDA were recalled when widespread use revealed their potential to cause serious or lethal side effects. Physicians are still prescribing many FDA approved drugs that will probably be recalled in the future.

For all of human history, medicine has been a giant, continuous experiment. For the past four to five generations, we've all been chemistry lab guinea pigs. Some drugs and vaccines have greatly improved survival and longevity. There have also been casualties along the way. But if we're fortunate enough to have the knowledge and means to access current healthcare options we can live free of polio, smallpox and rheumatic heart disease, and survive diabetes, cancer, and many other debilitating infections and conditions that steal health and lives.


While it's terrible that some people's vision was damaged by a particular application of stromal vascular fraction, I'd like to know if the FDA has attempted to ascertain how many people have been helped by use of this product? It has always been true that one person's panacea may be another's poison, but penicillin has still saved far more lives than it has taken.

Since my 2018 illness, when I last perused Pubmed about vascular stromal fraction, there are hundreds of newly published papers showing that this product has enormous potential for successful treatment of skin and bone defects, and neurodegenerative, auto-immune, cardiovascular and other devastating diseases. Emerging research indicates that adipose tissue derived stromal vascular fraction is far more likely to be beneficial than harmful, and its use may be safer and more efficacious than stem cells derived from bone marrow or amniotic fluid.

As global data collection improves knowledge about successful prevention and treatment of illness and injury, other FDA approved treatments will come to be seen as useless or harmful, and many new approaches will be tried. When not destroyed in turf wars, some entrepreneurs will develop new proprietary methods to help hopeless humans conquer diseases that currently have no cure. Some will succeed. Some will fail. Either way, the FDA needs to support this experimentation instead of applying outmoded regulations to suppress it, at least in the cases of patients who are facing long term care or death.

Absolutely nothing positive can be accomplished by destroying the stem cells that this lab has been banking for at-risk patients like me. If this lab cannot be rehabilitated to perform its highly valued role in pioneering stem cell techniques, than the FDA should install management that can properly handle the material, or turn the cells over to a lab they approve of and give patients like me a chance.

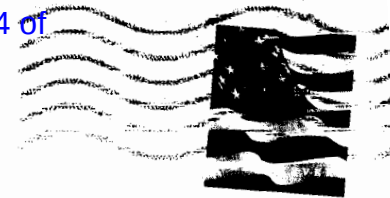

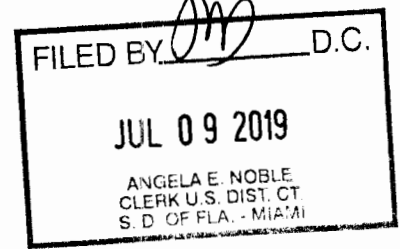

Please respond you received this email and ensure that what is my son's and no one else's is not destroyed but preserved.

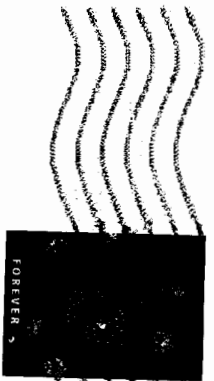

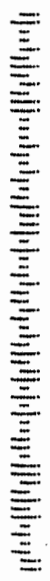

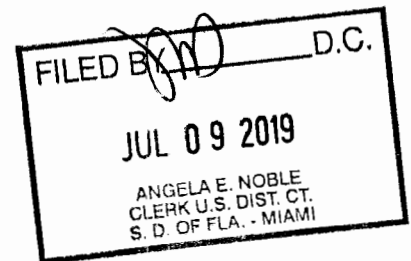

Your Honors:

I am writing to you today regarding the above Order and Injunction that was passed on June 25, 2019, by US District Judge Ursula Ungaro. This order effects me directly as my stem cells are being stored at the US Stem Cell facility in Florida.

I suffer from several autoimmune disorders, including but not limited to Hashimoto, Chronic Fatigue, Fibromyalgia, as well as ulcerative colitis, and IBS. It seemed that once I was diagnosed with the first one every year it seemed to be another one. I had exhausted all of the means that were presented to me by allopathic medicine over 10+ years and nothing was controlling or even helping it, most medications were making it worse. It got so bad in 2013 that I was bedridden for the last two months and into early the following year. After this I was never able to fully recover and work a full-time job. By late 2015/2016 I applied for disability I was having a hard time caring for myself, my brain fog had become so bad that I stopped socializing and became homebound, I had all but given up on any sort of normal life.

In my time alone I began to research alternative treatments for chronic diseases. I stumbled upon a documentary about Hashimoto's disease and it was here that I first heard about using our own stem cells to heal.

Soon after I found Seattle Stem Cell in Seattle, WA, where I found the Dr. In the documentary that was offering a patient funded study for FDA approval of stem cells. Under the care and expertise of Dr. Tami Meraglia, a double board certified MD that I had my harvesting of the fat cells and first deployment of my own stem cells done. Now, it is my understanding that the court is about to take away my rights to my own tissues (not the tissues of others or other family members) and are ordering US Stem Cell to destroy them. The cost of harvesting and the four deployment was about \$15,700. These figures do not include the costs of travel to have the deployments done. The cost of storing the cells is \$250 per year. I would never be able to afford the cost of harvesting again, that is why I opted to store my stem cells. This did not cost the taxpayers, it cost the individuals out of their/our own pockets in hopes of helping ourselves and others the right to choose the treatments they want in the future.

Some women choose to harvest and freeze their eggs to prolong their time of conception before starting a family and are allowed this opportunity. Please think of this as being the same. I know that some Cancer treatments, in allopathic hospitals in Canada, have involved the use of the same procedure of stem cells after chemotherapy in treatment for multiple myeloma. Having the use of our cells is giving us the right to choose our own treatments. Our bodies, our choices to use it to heal.

I beg you all to reconsider this Order and Injunction. All of the good progress, that I and others like me have made, may be lost.

My name is Terry Kita. I am a patient of Dr. Andrey Luthowski located in Birmingham, Michigan. I am 71 yrs. old.

On June 4, 2019 I had adipose fat cells removed from my abdomen and injected into my knees. 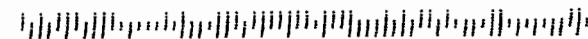

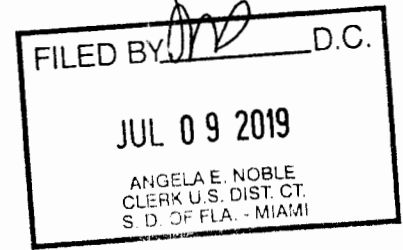

I recently learned that on June 25, 2019, you directed US STEM CELL, INC, US STEM CELL CLINIC, LLC by Order and Injunction to no longer receive, process, and distribute SVF Product. This action affects me since I have stored my stem cells with this company. There was no definitive reason for this action other than what I believe to be the FDA wants to control their use. 

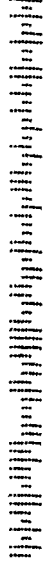

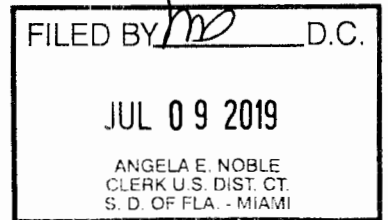

I respect the court's opinion, but I must point out that this tissue is my own tissue, extracted, stored, and injected back into my left hip joint when needed to create a cushion so I can walk without pain. I believe the FDA should not control my cells, or that they can decide that these cells, inside or outside of my body should be controlled by them. I care about my rights over my body and tissues and respect the healing power of my own cells to be able to heal where placed. These cells are mine, and it should be my choice, and the choice of those of us who have had this procedure to speak up and let you know about the healing power of our own stem cells.

I started my treatment in November 2018 with the extraction of the adipose tissue and the first injection in my left hip. The second, prepared by U.S. Stem Cell, was injected in February 2019 again in my left hip. I have gradually been able to decrease pain, increase range of motion, and strengthen the hip and leg.

If my tissue is destroyed, I will not only lose the option of more healing injections but lose my \$10,000 investment for the procedure and storage of the cells for future use.

Recategorizing my stem cells isolated during my surgical procedure as "a drug" will prevent me from having access to this treatment. I am not able to have a hip replacement due to health issues. There isn't any surgery that is subject to FDA approval, and this adipose-derived stem cell procedure shouldn't be the first one.

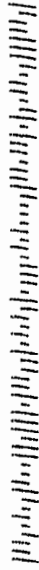

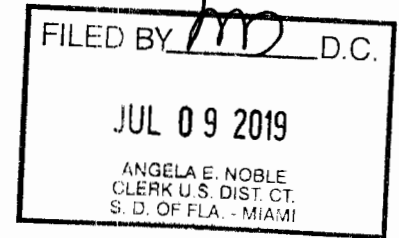

Dear Judge Ungaro,

I am writing to you in hopes that you may be persuaded into modifying the Order and Injunction issued against U.S. Stem Cell, Inc. The destruction of my, and others, stored stem cells could potentially result in fatalities.

My name is Paul Miller and I am 69 years old and reside in Michigan. In 2014 my COPD and Emphysema had progressed to the point that I could do nothing strenuous and was wearing an Oxygen mask 24 hours a day. My condition continued to worsen and I was literally dying a slow death. I received stem cell treatment at U.S. Stem Cell Clinic in 2015 and my condition began to improve almost immediately. My pulmonologist believed the improvement to be merely a placebo effect. Now after 3 pulmonary function tests (PFT), each one with better results than previous, she knows that is not the case and will refer patients for treatment there. I myself have told several people how I got better and they too have improved the state of their health with the treatments they have received. People in my family are benefiting from the stem cell treatments they have received there too.

There are no documented results because the clinical trial I enrolled in, approved by the National Institute of Health, is patient funded. That requires everyone to get the treatment they paid for so there is no control group, which receives a placebo, to compare with. Big pharmaceutical companies would not fund the type of clinical trial or study necessary for documented results because stem cell treatments seek to cure, and there is no profit for them in that. They make their money on drugs you take daily for the rest of your life. None of the Doctors I consulted with before getting treatment were aware that stem cells were being used in this manner. It is a terrible shame that the truth of the effectiveness of these treatments is so slow to reach the public because no one will bear the cost of a thorough study.

Please reconsider your destruction order of mine, and all the others, stored stem cells. These are my own cells, removed from my body and stored at my expense. There can be no public benefit derived from the destruction of this personal property. The destruction can only result in harm to all of us who look forward to future treatments. There are many whose health situation is worse than mine, like my brother who suffers from Parkinson's disease. He has benefited greatly from the use of his own stem cells. Therefore, I implore you to please consider modifying the Order and prevent the destruction of the cells banked at U.S. Stem Cell Clinic. Lives seriously do depend on it.

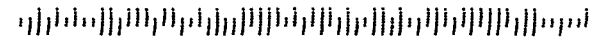

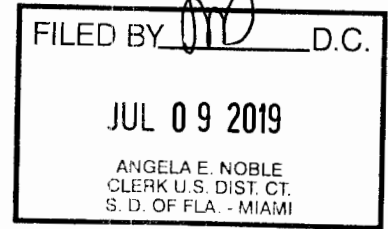

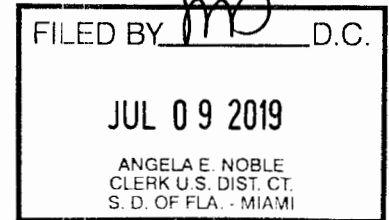

This treatment works!!!



RE: the Order and Injunction on June 25, 2019 by District Judge Ursula Ungaro in the USA vs US Stem Cell Clinic and others, Case 18-cv-61047-UU:

I wish to voice my objection to the decision that was made in this case. My stem cells are not a drug.
